1 Defendants Archbishop C. Eugene Kaplan, Patriarch Mar Ignatius Zakka I, and the Syrian
2 Orthodox Patriarchate of Antioch Archdiocese of the Western United States (erroneously sued herein
3 as "Syrian Orthodox Patriarch of Antioch Archdiocese of the Western United States") were represented
4 by Joel A. Goldman of Lewis Brisbois Bisgaard & Smith, their attorneys of record.

5 After the presentation of evidence by Plaintiff and the conclusion of Plaintiff's case in chief, the
6 Court entertained a motion for nonsuit brought by Defendants pursuant to Code of Civil Procedure
7 section 631.8. After hearing oral argument on Defendants' motion, the Court ruled that Plaintiff had
8 not met its burden of proof by failing to present any credible evidence of any harm or potential harm
9 to Plaintiff or that Defendants had inflicted any injury on anyone to merit an accounting or justify any
10 declaratory relief. Based thereon, the Court therefore granted Defendants' motion for nonsuit for all
11 of the reasons set forth by Defendants in their motion, other than the issue of Plaintiff's standing.

12 Accordingly, based upon the foregoing, and good cause appearing therefor, it is hereby

13 ORDERED, ADJUDGED AND DECREED that Plaintiff shall take nothing by way of its
14 Complaint herein, and that Defendants shall have and recover their costs of suit incurred herein.
